

Budget Express Delivery Contract

BUDGET EXPRESS DELIVERY CONTRACT CONDITIONS

1. You hereby acknowledge that you have the right to benefit from the system which ensures the customers who rents a car online to pick up their vehicles expressly from the vehicle park (hereafter shall be referred as express delivery) from Otokoç Otomotiv Tic. ve San. A.Ş. (hereafter shall be referred as **Budget**) providing car rental services with **Budget** brand provided that these Terms and Conditions are executed and you fulfill the following conditions.

1.1. You are obliged to sign and submit all documents related to the rental as requested by **Budget** together with these Terms and Conditions. You hereby acknowledge that you cannot rent vehicles only based on these terms and conditions in the event you do not sign the documents related to the rental as submitted to you by **Budget**.

1.2. You hereby acknowledge that you shall not have to go to **Budget** offices for reservations you made from **Budget's** website (budget.com.tr) and call center (**444 4 722**) provided that this contract is signed and rental documents are submitted.

1.3. You hereby agree that if Express Delivery service is used, rental fee shall only be paid at the moment of reservation by you, issues related to return of the fee shall be conducted as stated in budget.com.tr website, your driver's license shall be checked again when you pick up the vehicles from **Budget's** parking lots, no additional Rental Contract printout shall be submitted to you, you shall sign the delivery documents submitted to you by the Budget official in the event of confirmation of your reservation and details, and these documents constitute evidence of you picking up the vehicles.

2. You hereby accept and guarantee that you shall not act against the General Sales Conditions submitted to you when picking up the vehicles for

rental, and these terms and conditions shall be applicable under any conditions.

3. You hereby accept that Istanbul Anatolian Courts shall have the exclusive right for judgment for all kinds of dispute arising from these Terms and Conditions or any Rental Contract as against **Budget** and any **Budget** branch in Turkey as permitted by laws.

4. You hereby accept that these Terms and Conditions or all Rental Contracts, delivery form bearing your signature as submitted to you at the moment of delivery of the vehicle as well as all communications (including reservation confirmations) related to Rental Contracts made by electronic communication (including e-mail and telephone) shall be lawful evidences as long as they are applicable. Even if it is required to deviate from all kinds of written evidence rules for this kind of procedure, **Budget** shall have the right to obtain its own electronic records to prove the contents of the contracts you have signed with its offices.

5. For the avoidance of doubt, aforementioned express delivery service shall be applicable at offices selected by **Budget** and announced on its website budget.com.tr. **Budget** has the right to change these offices from the website budget.com.tr at any time.

6. You hereby accept that acceptance of these Terms and Conditions and all correspondences related to future rental contracts (including reservation confirmations) can be made via all kinds of electronic communication methods.

7. You hereby acknowledge that we have the right to amend the Terms and Conditions upon a written notification to be sent to you in printed or electronic form or upon publishing these kinds of changes on budget.com.tr website, and amended conditions shall be applied for rentals to be made after sending these amendments as of the date of notification.

8. The person(s) who undertake the rights and obligations conferred to them within the frame of these terms and conditions are the person(s) having the title customer (lessee), and they hereby accept and guarantee that they have read, understood and approve all terms and conditions hereby.
